#### (b) Police Report / District Councillor / County Councillor

PCSO Jonathan Flowers attended the meeting. During April 2023 there were three reported crimes, including 1 incident which included a theft and criminal damage and 1 vehicle crime. It was reported that for knife crime awareness week there will be chalk messages on play areas, this may include Holmesfield. PC Matthews has now got a new speed gun and this will be used throughout the Parish to keep residents safe. Also a request has been submitted to the highway authority to make changes to the road outside Penny Acres School to make it safer to cross.

(c) The Chief Executive and Enforcement Officer of the Peak District National Park Authority attended to discuss the caravans and other development at Owler Bar. They have apologised for the time that is has taken to establish ownership and because of total lack of engagement the process has been protracted. In February 2023 a Planning Contravention Notice was issued to try and establish if there is any agricultural use. As this has not been returned then a planning breach will be served and the Parish Council will be notified when this has been done
