District Councillor Bentley Stafford-Stephenson attended the meeting. Within the area he has been dealing with some housing and noise issues in Barlow, and reported that the planning issues at Brindwood House are to be dealt with via a public inquiry, the timescale for the proceedings is not yet known.
