PC Julian Matthews attended the meeting, there is some discrepancy with the crime figures, clarification will be sent through.

Various speed checks have been taking place with both the camera and the crest videoing. Tickets have been issued outside Penny Acres School.

Various matters were discussed including that traffic ticketing on the double yellow lines at the top of Cowley Lane is under the jurisdiction of Derbyshire County Council.

The issue of pollution being caused by cars idling outside the school and pavement parking not being illegal as long as there is reasonable room for pedestrians.

The issue of speeding in the village was raised, especially on Fox Lane and the Cordwell Valley. There is a way of sending dashcam footage through to the Police and this will be included in the newsletter.
