(a) Members of the public

Two members of the public addressed the meeting with regards to how dangerous it is for horse riders in and around the parish, There have been a number of injuries to both riders and horses due to the dangerous driving of vehicles. They are looking at ways to publicise to motorists including signs for the highway, and sign on private land.

They were invited to put an article in the newsletter outlining the issues.

As part of Operation Sceptre - stencilled chalk marks are to be used in the parish including the play area; this is to help raise awareness of knife crime.

A request was put forward for the Parish Council to purchase an automatic number plate recognition camera in the village to aid with crime prevention. The approximate cost for a unit with a six year lifespan is £4000.
